Increased product regulations globally








Some regions more growth than others

Increased regulations vs deregulation










Product Security and Telecommunications Infrastructure Act 2022 (PSTI)

Product Safety and Metrology Bill (PSMB)

- Associated regulations
- Increased requirements for connected products
- A glimpse of the approach to be taken for the new PSMB?

- New framework law & likely only a starting point
- Cross cutting hazards
- Digital labelling

Australia: Review of Online Safety Act, Treasury Laws Amendment Bill 2024 – Product Safety Regulation

Trends in legal risks







Legal risks in the "new age"



Legal obligation triggered (corrective action and regulatory reporting) Regulatory investigation and enforcement



Civil litigation including group (or "class") action





Corrective action and regulatory reporting Triggering of legal obligations

General increase in corrective action and regulatory reporting – 7,000+ recalls notified via EU Safety Gate in first 6 months of 2024 (a record-breaking year)

Thresholds for reporting/corrective action changing

Increasingly divergent approaches globally

Increased number of actors in the supply chain responsible separately for obligations

Increasingly complex and voluminous requirements






Regulatory investigations and prosecutions

- **01.** Jurisdictions with focus on enforcement vs increased regulation
- **02.** Publication of enforcement policies and practices
- **03.** Overlapping laws and multiple regulators
- **04.** Publicity and damaged brand reputation
- **05.** Financial and criminal sanctions applicable






Litigation

- **01.** Convergence between litigation and regulation
- **02.** New causes of action / rights of recovery outside product liability regimes
- **03.** Reversal of onus of proof / lower proof threshold for claimants in product liability
- **04.** Rise of class actions



Mitigation strategies





Future-proofing

Minimising product regulatory and litigation risk

02

01

Review supply chains

Review contracts to ensure they effectively manage any regulatory action and/or civil liability. Ensure robust due diligence.

Responsibility and obligations of parties should be clearly defined, including information sharing.

Build and maintain strong working relationships with suppliers to aid managing possible disputes or crises.

Review product portfolio

Check products against requirements under existing and new regimes.

Ensure timelines for new requirements are tracked and implemented into product development process (there is a lot of upcoming changes through to the end of 2026).

03

Track regulatory developments and litigation risks

Track applicable regulations and implementation timelines by jurisdiction.

Track relevant regulatory decisions and enforcement actions.

Track new emerging litigation risks, including class actions.

04

Review crisis management protocols

Review (or produce) crisis management protocols and test them.

Ensure effective information flow, systems and working relationships between internal compliance and legal teams.

05

Consider litigation strategy globally

Ensure disclosure and statements made across the jurisdictions are as streamlined as possible to normalise litigation risk strategy


Ensure the above mitigating strategies are applied on a regular periodic basis (at least annually)







